Bloomingtondale Quarry History

- Bloomingtondale Quarry began in the 1800's as a dimension stone quarry for decorative and building stone under the name Pompton Pink Granite Company
 - The granite deposits are around 1 BILLION years old
- The stone was prized for its unique coloring, coarse grain size, and structural stability

Bloomington Quarry History

- 1957 - After mining all the pink granite, quarry was sold to Passaic Crushed Stone.
 - Quarry was expanded by the Gallo family over three generations
 - Produced aggregate crushed stone and asphalt

- 2004 - Quarry was bought by Tilcon from Passaic Crushed Stone

Working Together

- Tilcon will continue to work with the Borough of Bloomingdale to secure the quarry's ability to sustainably serve the needs of you, the Borough, County, and State for generations to come.
- Purchase of the Meer Property
 - 180 Acre Parcel
 - 35 acres will be deeded to the Borough for Affordable Housing consistent with a Superior Court Order
 - Provides an increased buffer for future housing/commercial development
- Long term, provide a desirable development opportunity

Benefits to Borough of Bloomingdale

- Tax Revenue
 - Tilcon will continue to pay significant tax revenue to the Borough
 - Positive Ratable
 - ✦ Taxes generated exceed the municipal costs necessary to support the new development
- Land Donation for Affordable Housing Development (“AHD”)
 - A portion of the Meer tract will be cleared, prepped, and graded by Tilcon
 - Deeded back to Borough to meet AHD requirements mandated by Superior Court
 - Sale of the AHD land by Borough to a developer results significant financial gain
- Minimal impact on Borough services
- Increased growth opportunity

- All of the agencies listed above inspect the quarry operations at random several times a year

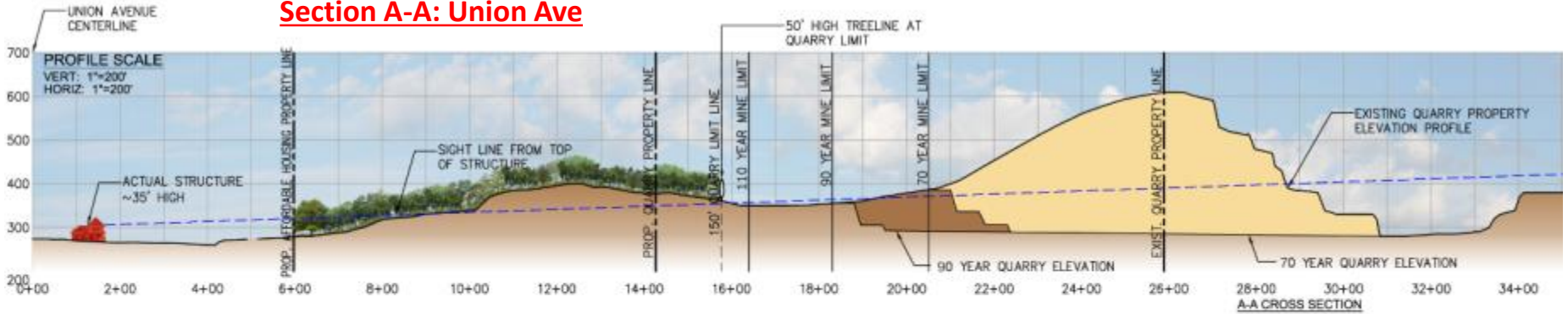

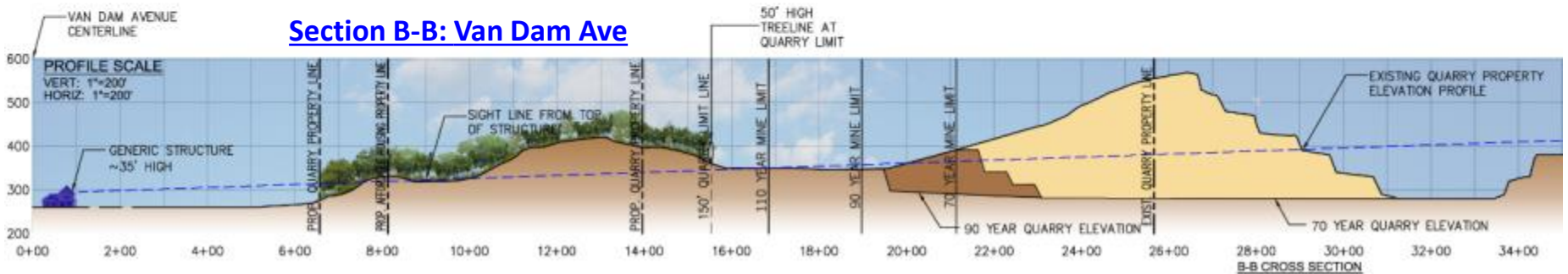

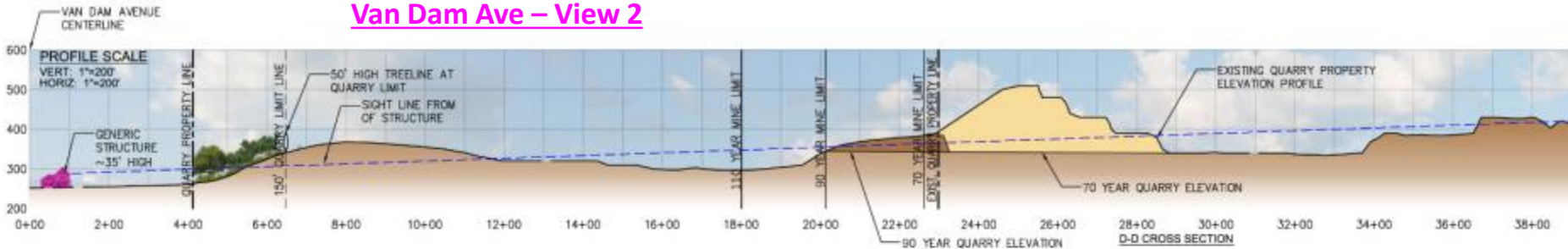

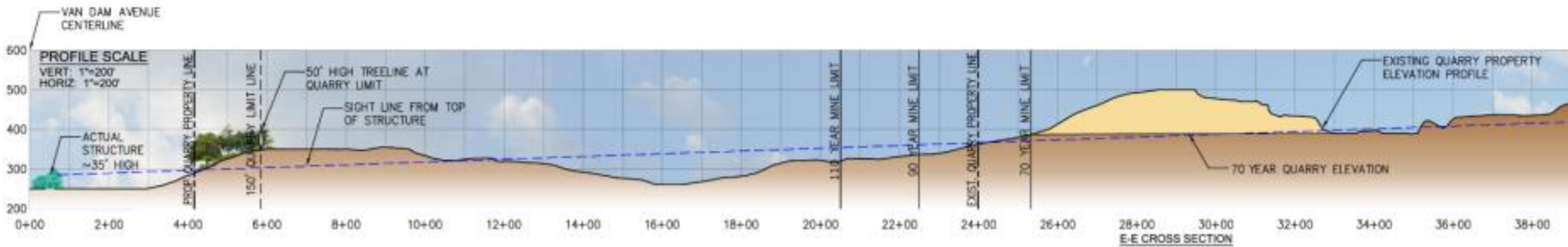

Large Salmon Stocked in Tilcon Lake, Morris County

April 22, 2014

The NJDEP Division of Fish and Wildlife has announced that Tilcon Lake received its first stocking of landlocked salmon on April 17. Nearly 200 large salmon, averaging 18 inches and ranging in size from 15-20 inches in length, were stocked in the Morris County lake.

The salmon, averaging about 2¼ pounds, with some nearly 3½ pounds, had been growing at the [Hackettstown State Fish Hatchery](#) since their arrival last May. The salmon had been fed a high protein, pelleted diet and fathead minnows to prepare them for release into the wild. Since the salmon program's beginning in 2006 the [Massachusetts Division of Fisheries and Wildlife](#) has been providing us with surplus fingerling salmon every May, free of charge.

Located in Mt. Olive Township, within [Allamuchy Mountain State Park](#), Tilcon Lake is the newest (2014) addition to our Holdover Trout Lake roster. When the Musconetcong River breached its banks during severe flood events in the early 2000's, water from the river inundated this former quarry creating the lake. The lake is approximately 50 feet deep at its deepest point. As its history as a former quarry suggests, the shoreline is rugged (steep, sometimes vertical slopes) and the lake bottom drops off quickly from the shoreline into deep water (currently there is no contour map of the lake bottom available).
