

The Board of Education of the Borough of Bloomingdale in the County of Passaic, New Jersey is authorized (a) to undertake various improvements and renovations at the Martha Day Elementary School and at the Walter Bergen Middle School, including the acquisition and installation of equipment and any necessary site work; (b) to appropriate \$1,341,950 for such improvements funded, in part, by grants from the State of New Jersey in the aggregate amount of \$536,780; (c) to issue bonds of the School District in the principal amount of \$805,170; and (d) to transfer local share funds between the school facilities projects.

The final eligible costs for the proposed improvements approved by the New Jersey Commissioner of Education are \$1,341,950 (\$722,441 allocated to the Martha Day Elementary School and \$619,509 allocated to the Walter Bergen Middle School). The proposed improvements do not include school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G.
