

# Passaic County New Jersey Community Block Grant Program-Disaster Recovery Program as funded by the New Jersey Department of Community Affairs

#### Community Development Block Grant-DR

### **Wayne Township: Hoffman Grove-Acquisition/Demolition**

Funds will be used to acquire and demolish 17 homes to create parkland. The Township's intention is to buyout and convert as much of this area to parkland as possible. The area is isolated by the NJ Boynton Branch line. Although access is limited to Main Road, residents of the surrounding area within 2463 BG 4 and 2463 BG 1 are expected to access this park area.

APPROXIMATELY \$1,839,351 in CDBG-DR funds will be used to fund the project.

#### Wayne Township: Buttonwood-Acquisition/Demolition

Funds will be used to acquire and demolish 2 homes to complete the buyouts and finish the open space project. The township has acquired and converted the land surrounding these two properties to park area. .

APPROXIMATELY \$160,649 in CDBG-DR funds will be used to fund the project.

## Pompton Lakes: Acquisition/Demolition

Funds will be used to buy out 15 homes and elevate 12 homes in a floodplain. The improvements must be located in the floodplain because the 27 residences within the Borough of Pompton Lakes have been damaged from repetitive floods. Some of the residences are located within the base or one percent chance floodplain (also known as the 100-year floodplain). Some of the residences are located within the floodway. The proposed undertaking is to elevate the 12 structures within the Township and buyout and demolish 15 of the structures. The elevation of structures may include repair, reconstruction, restoration, retrofitting, upgrading to current codes and standards, or replacement of any facility in a manner that substantially conforms to the preexisting design, function, and location. Once the 15 homes are purchased and demolished, the land will remain open space.

APPROXIMATELY \$510,000 in CDBG-DR funds will be used to fund the project.

#### **Little Falls Township: Acquisition/Demolition**

Funds will be used to acquire and demolish 13 single-family homes, demolish the homes, and complete site restoration work for use as an open space.

APPROXIMATELY \$2,000,000 in CDBG-DR funds will be used to fund the project.

#### Paterson City: Acquisition/Demolition

Funds will be used to acquire and demolish 8 homes to create parkland.

APPROXIMATELY \$2,000,000 in CDBG-DR funds will be used to fund the project.

#### Woodland Park Borough: Acquisition/Demolition

Funds will be used to acquire and demolish 3 homes to complete the buyout and add to the parkland.

APPROXIMATELY \$823,263 in CDBG-DR funds will be used to fund the project.

#### Totowa Park: Acquisition/Demolition

Funds will be used to acquire and demolish 5 homes.

APPROXIMATELY \$900,000 in CDBG-DR funds will be used to fund the project.

#### **Hawthorne Borough: Acquisition/Demolition**

Funds will be used to acquire and demolish 3 properties.

APPROXIMATELY \$821,602 in CDBG-DR funds will be used to fund the project.

#### **Bloomingdale Borough: Storm Sewer Reconstruction (Multi-year)**

Funds will be used to reconstruct the existing storm drainage system. The project is located in a low-mod area. The system was compromised by the effects of Hurricane Irene and need to be rebuilt. The reconstruction of the collapsed storm line near 125 Main Street will include the following:

- 1. Acquisition of Drainage Easement
- 2. Install a new Type "B" Inlet at the south curb line of Paterson Hamburg Turnpike.
- 3. Install approximately 48 linear feet of 14"x23" Elliptical Reinforced Concrete Pipe from the existing manhole to the new Inlet
- 4. Install approximately 160 linear feet of 14"x23" Elliptical Reinforced Concrete Pipe from the new inlet toward the river, following the line of the old 15" VCP
- 5. Install a concrete end treatment reinforced with Rip Rap slope protection

APPROXIMATELY \$200,000 in CDBG-DR funds will be used to fund the project. The project may require funds in future years.

#### Passaic City: Reconstruction of Storm Water Channel (Multi-year)

The Passaic City project will involve the remediation and upgrade of soil erosion along McDanold Brook. The project is located in a low-mod area. The entire project area would include: from the entrance of the box culvert from the Broadway side of 3rd Ward Memorial Park to a point at which it is underground at Main Avenue.

- 1. Engineering and Design
- 2. Conduct hydrological study on water flow from box culvert
- 3. Restore lower stream bed to original depth
- 4. Install storm water piping to straighten out water flow at streams curve point
- 5. Reconstruct stream wall
- 6. Rehab pedestrian walking bridge and replace pedestrian pathway
- 7. Remediate soil erosion
- 8. Address drainage from grassy surfaces
- 9. Re grade adjacent stream land surface and elevate

APPROXIMATELY \$2,000,000 in CDBG-DR funds will be used to fund the project. The project may require funds in future years.
