* Maximum lot coverage- That portion of the lot which is improved or is proposed to be improved **with principal and accessory buildings or structures or driveways, paved or otherwise, decks or porches, pools, patios, parking lots, pedestrian walkways, retaining walls, fences, signs or other manmade improvements on the ground surface, excluding lawns or other landscaping improvements.**

** Maximum Building Coverage- That area of a lot which is directly occupied by a building or structure, **but not including uncovered walkways, steps, patios, decks, pools, driveways, parking lots or any similar improvements thereof.**

Minimum habitable dwelling spaces: (R-10: 1,100sf) (R-20: 1,200sf) (R-40: 1,400sf) (R-130: 1,400sf) for new dwellings
