2025 RECYCLING AND GARBAGE INFORMATION

DPW 188 Union Ave | 973-838-6055 | Hours: 6:00am to 2:00pm

COLLECTION SCHEDULE: Materials shall be placed at the curbside no sooner than 6:00 p.m. the day prior to scheduled collection and no later than 6:00 a.m. on the day of scheduled collection. Empty containers or unaccepted materials must be removed from the curb no later than 8:00 p.m. on the day of scheduled collection. No garbage or recycling on holidays. See calendar.

Household Garbage and Recycling must be in a 32-gallon, sturdy container with handles, with tight-fitting lid, 60 lb. limit. No more than 4 garbage containers or equivalent. BULK is your second pick up day with NO MORE THAN 4 ITEMS PER PICK UP!

Absolutely no garbage is to be dumped at the DPW!

COMMINGLED RECYCLING CONTAINERS [Collection Schedule for 2025 is on calendar.](#)
(EXAMPLE: Plastic Milk, Soda Bottles, Glass Containers and Aluminum/Tin Cans)



MUST be in sturdy metal or plastic trash containers only.
MUST be cleaned and rinsed.
MUST crush plastic milk and soda bottles.
NO plastic or paper bags and NO plastic caps
NO plate glass, oil containers, ceramics or Styrofoam

Absolutely NO Construction Materials will be picked up. Residents are responsible for obtaining private company containers for these items, i.e., sheetrock, windows, shingles, etc.

PAPER, NEWSPAPERS, TIRES AND METAL ITEMS

Residents are encouraged to dispose of their recyclable paper, newspapers and electronics at the DPW Yard on Saturdays between 8:00 a.m. and 12:00 p.m.

Curbside Pickup - Paper and cardboard should be in a recyclable container or in paper bags (**twine or tape should not be used**). Cardboard must be broken down and flat.

Residents must register for the collection of tires, metal appliances and other large metal items by calling 862-328-6236 at least two (2) days prior to the following scheduled tire and appliance collection dates.

AUTOMOTIVE/HAZARDOUS MATERIAL

TIRES: The Borough will accept passenger vehicle tires **without rims only**. No truck tires will be accepted. **Residents must pay a \$5.00 disposal fee** per passenger vehicle tire when registering.

CAR OR TRUCK BATTERIES: Drop off at DPW Yard on Saturdays only between 8:00 a.m. and 12:00 p.m.

PAINT DISPOSAL: Add kitty litter or paint hardener to paint, once it becomes hard you can leave at curb with lid off. Dispose of paint on your regular garbage pick-up.

LANDSCAPING ITEMS

ABSOLUTELY NO CONTRACTORS WILL BE ALLOWED TO DUMP AT THE DPW YARD.

BRUSH AND YARD WASTE: Tree limbs and twigs must be tied in 4ft lengths and placed curbside. No tree trunks or stumps will be accepted. Christmas trees will be picked up curbside.

GRASS CLIPPINGS AND LEAF COLLECTION: Please be advised that the borough requires all grass clippings, leaves and weeds to be put in paper bags, **NOT PLASTIC**, and will be picked up curbside weekly.

When picking up mulch/soil from the DPW Yard, please load it by hand! Contractor trucks or equipment cannot be brought onto borough property.

Noncompliance may result in property maintenance fines and summonses.

SOLUTIONS TO STORMWATER POLLUTION

Easy Things You Can Do Every Day to Protect Our Water

A Guide to Healthy Habits for Cleaner Water

Pollution on streets, parking lots and lawns is washed by rain into storm drains, then directly to our drinking water supplies and the ocean and lakes our children play in. Fertilizer, oil, pesticides, detergents, pet waste, grass clippings: You name it, and it ends up in our water.

Stormwater pollution is one of New Jersey's greatest threats to clean and plentiful water, and that's why we're all doing something about it.

By sharing the responsibility and making small, easy changes in our daily lives, we can keep common pollutants out of stormwater. It all adds up to cleaner water, and it saves the high cost of cleaning up once it's dirty.

As part of New Jersey's initiative to keep our water clean and plentiful and to meet federal requirements, many municipalities and other public agencies including colleges and military bases must adopt ordinances or other rules prohibiting various activities that contribute to stormwater pollution. Breaking these rules can result in fines or other penalties.

As a resident, business, or other member of the New Jersey community, it is important to know these easy things you can do every day to protect our water.

Limit your use of fertilizers and pesticides.

- Do a soil, test to see if you need fertilizer.
- Do not apply fertilizers if heavy rain is predicted.
- Investigate alternatives for pesticides.
- Maintain a small lawn and keep the rest of your property or yard in a natural state with trees and other native vegetation that requires little or no fertilizer.
- If you use fertilizers and pesticides, follow the instructions on the label on how to correctly apply it. Make sure you properly store or discard any unused portions.

Properly use and dispose of hazardous products.

- Hazardous products include some household or commercial cleaning products, lawn and garden care products, motor oil, antifreeze, and paints.
- Do not pour any hazardous products down a storm drain because storm drains are usually connected to local waterbodies and the water is not treated.
- If you have hazardous products in your home or workplace, make sure you store or dispose of them properly. Read the label for guidance.
- Use natural or less toxic alternatives when possible.
- Recycle used motor oil.
- Contact your municipality, county or facility management office for the locations of hazardous-waste disposal facilities.

Keep pollution out of storm drains!

- Municipalities and many other public agencies are required to mark certain storm drain inlets with messages reminding people that storm drains are connected to local waterbodies.
- Do not let sewage or other wastes flow into a stormwater system.

Clean up after your pet!

- Many municipalities and public agencies must enact and enforce local pet-waste rules.
- An example is requiring pet owners or their keepers to pick up and properly dispose of pet waste dropped on public or other people's property.
- Make sure you know your town's or agency's requirements and comply with them. It's the law. And remember to:
 - Use newspaper, bags or pooper-scoopers to pick up waste.
 - Dispose of the wrapped pet waste in the trash or unwrapped in a toilet.
 - Never discard pet waste in a storm drain.

Don't feed wildlife!

- Do not feed wildlife, such as ducks and geese, in public areas.
- Many municipalities and other public agencies must enact and enforce a rule that prohibits wildlife feeding in these areas.

Don't litter!

- Place litter in trash receptacles.
- Recycle. Recycle. Recycle.
- Participate in community cleanups.

Dispose of yard waste properly

- Keep leaves and grass out of storm drains.
- If your municipality or agency has yard waste collection rules, follow them.
- Use leaves and grass clippings as a resource for compost.
- Use a mulching mower that recycles grass clippings into the lawn.
